I agree to pay Horizons East, Inc. \$\_\_\_\_\_ per month for board, \$\_\_\_\_\_ per month for miscellaneous/supplies, \$\_\_\_\_\_ grooming, and \$\_\_\_\_\_ per month for training for the above listed horse. The rider is subject to the following conditions:

1. Board is to be paid by the fifth of each month, training is to be paid by the twentieth of each month, or late charges will be added.
2. During the term of this agreement and any extended term, Horizons East, Inc. Agrees to provide the Owner's horse with substantially the same care and treatment as it provides for its own horses, including veterinary and farrier services.
3. In no event shall Horizons East, Inc. be responsible for any loss, theft, injury or death of the horse.
4. Owner agrees to look solely to his/her own insurance, if any, which owner may carry on the horse at his/her own expense.
5. Owner agrees to promptly pay for routine shoeing scheduled by Horizons East, Inc., as well as veterinary examinations, worming, vaccinations or other outstanding charges incurred by Horizons East, Inc. for the above named.
6. Owner authorizes Horizons East, Inc. to incur all reasonable expenses necessary to administer emergency first aid to the above named horse.
7. Owner agrees not to remove the horse without giving Horizons East, Inc. 15 days notice and further agrees to satisfy all outstanding statements incurred by Horizons East, Inc. for the care of the horse. A horse staying with Horizons East Inc. for a period less than 15 days will be charged a daily rate along with any associated expenses.
8. Owner shall pay a one-month deposit upon arrival for board. 50% of the fee is retained under all circumstances to cover standard maintenance and repair, and the remaining 50% will be credited to the last month's charges, as long as all of the bills have been paid.
9. Horizons East, Inc. shall have a general lien on Owner's horse for any amount due under this agreement, and the lien may be enforced by Horizons East, Inc. by sale of the Owner's horse.
10. Owner shall indemnify and hold and save Horizons East, Inc. its directors, officers, agents and employees harmless from any and all liability on account of any claim whatsoever, for damages and injury to persons, horses, or property arising in connection with any activity conducted or undertaken by Owner, Owner's family, guests, agents or employees under the terms of, or in connection with this Agreement.
11. No jumping unless the rider is attending a lesson.

I HAVE CAREFULLY READ THIS AGREEMENT AND FULLY UNDERSTAND ITS CONTENTS. I AM AWARE THAT THIS IS A RELEASE OF LIABILITY, INCLUDING ASSERTED NEGLIGENCE, AND A CONTRACT BETWEEN MYSELF AD HORIZONS EAST EQUESTRIAN CENTER, HORIZONS EAST SHOW STABLES AND HORIZONS EAST, INC. I SIGN IT OF MY OWN FREE WILL.
